On December 28, 2005, Defendants Abusive Hosts Blocking Lists, AHBL.ORG, The Summit Open Source Development Group, Andrew D. Kirch, D&K Consulting, and Trelane.net (the "Kirch Defendants") filed a Special Appearance in this case. The Kirch Defendants moved, in Open Court, that their Special Appearance be heard prior to the hearing (the Motion") on the Plaintiffs' Request for Temporary Injunction, based on Plaintiffs' previously obtained Temporary Injunction. The Court, after hearing the Motion, and the argument of Counsel and Mr. Scoville, finds that because the Special Appearance involves jurisdictional issues to be resolved, is of the opinion that the Motion is well-taken, should be, and it is hereby GRANTED.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that:

3. All relief not expressly granted in this Order is denied.


